EVENTS

On Parliaments in War and Revolution

The Center for Historical Research at St. Petersburg Higher School of Economics, member of EuParl.net since 2017, hosted an international workshop on Parliamentarianism and Representative Democracy in Crisis of War, Revolution and Collapse of Empires on 2 October 2018. The keynote lecture by the Center's director Alexander Semyonov

offered a differentiated history of Russian parliamentarianism. It focused on the idea of political representation in social and political crisis of 1905/1906 which enabled the election of the Imperial State Duma, the first Russian parliament, and its relative success in modernising the transit Empire.

Pasi Ilahainen (University of Jyväskylä,

Finland) diagnosed constitutional reforms in Britain, Germany, Sweden and Finland as the "springs of democracy" resulting from the First World War and the Russian Revolution. Jure Gašparič (Institute of Contemporary History, Slovenia) analysed the fragility of representative democracy in interwar Yugoslavia, using its different parliamentary buildings as communicators of political convictions.

Century of Women MPs

On 5–7 September, University of Westminster and the History of Parliament Trust in London hosted a conference titled *Century of Women MPs*. An international event commemorating the extension of electoral rights of 1918 in the UK drew an intriguing picture of British female pioneers in Parliament, and of later presence of women in politics. EuParl.net was there too! Carla von Baalen from the Dutch Centre for

Parliamentary History described the conflict about women's employment in the Dutch parliament in the 1950s. Adéla Gjuričová from the Czech Institute of Contemporary History talked about the puzzle of female representation in Communist legislatures.

The British perspective dominated – as befalls a fine host. The papers discussed early periods when, in order to be elected, women MPs virtually had to be wives of former MPs; times when women joined men in hunger marches and

strikes to at last make their way to the Commons; and recent modes of physical discrimination of female deputies in British Parliament. The first-past-the-post system and its effect on the proportion of women MPs was another key topic: in 1997 the Labour Party first used the "all-women shortlists" that allow only women to stand in particular constituencies. This met with some controversy within the party, but finally opened the way towards the current 29 percent of female MPs in the Commons.

PROJECTS

A Bitter Return of Parliament



Adéla Gjuričová and Tomáš Zahradníček's *Return of Parliament* focuses on Czechoslovak Federal Assembly between the Velvet Revolution of 1989 and the break-up of Czechoslovakia in 1992. The publication concludes their extensive research into the last Czechoslovak parliament. The authors observe the code of business, traditions and "good manners" in the different phases of the legislature that was established in 1968, silenced until 1989, to become the new core of politics until the dissolution of Czechoslovakia in 1992.

The authors argue that the Federal Assembly as an institution serves as an excellent lens to explore anew Czechoslovakia during the 1989 revolution. The same perspective offers a lesser known account of the first months of post-Communist transformation and suggests quite a specific mode of disintegration of Czechoslovakia. With its focus on Slovak presence, the subtitle *Czechs and Slovaks in the Federal Assembly* serves far more than complimentary role. Even though the authors are Czechs based in Prague, they exerted utmost effort to consider Slovak perspective that proved to be eruditely critical about Czech politics and its leaders.

Dutch Parliamentary History Is 20

The 20th Yearbook of Parliamentary History is out now. On 20 November, the first copy of the Yearbook was presented in The Hague to the President of the House of Representatives, Khadija Arib, and the President of the Senate, Ankie Broekers-Knol. This year, the editorial board opted for a contrast between urban agglomeration and the countryside as guiding theme; hence the title Region versus Randstad. The event took place in the Binnenhof's Oude Zaal, the former plenary hall of the House of Representatives.
